The 4th congress aims to bring together various disciplines to address global challenges in organ transplantation.

FREE COMMUNICATIONS

We welcome abstract submissions on the following topics:

1. **ORGAN TRADE AND PAID DONATION** (e.g. incentives; Council of Europe convention; transplant for non-nationals; role of professionals; legislative and non-legislative responses).
2. **PEDIATRIC DONATION AND TRANSPLANTATION** (e.g. neonatal donation; age and discrimination).
3. **CULTURAL, RELIGIOUS AND SOCIAL ASPECTS** (e.g. disparities in access; public campaigns; policies and practice).
4. **LEGAL ASPECTS** (e.g. Israeli law; the EU directive; international kidney exchange).
5. **PSYCHOSOCIAL ASPECTS** (e.g. education; screening and follow-up; adherence and self-management; body image).
6. **ETHICAL AND PHILOSOPHICAL ASPECTS** (e.g. principles of allocation; principles of wait-listing; donation after euthanasia; scientific integrity and safety; research on deceased donors).
7. **LIVING DONATION** (e.g. anonymous donation; public solicitation; social media; informed consent; donor advocacy; promoting living donation; paired and chain donation).
8. **DECEASED DONATION** (e.g. tissues and cells; donor autonomy; definition of death; donor interventions; language of donation; opt-in versus opt-out).



The abstract submission opened on 1 July 2015 and the deadline is on 5 November 2015

The Scientific Committee invites authors to submit abstracts to be considered for inclusion in the programme.

PRESENTATIONS

Selected abstracts will be presented as oral presentations. Other submissions will be presented as posters.

For the first time the programme will include 2 days devoted to hot topics in living donation and deceased donation respectively.
