3. THE THEME OF THE 2025 MEETING

- Employ recent scientific developments in organ donation and transplantation in clinical practice.
- Analyze current clinical practice challenges in organ donation and transplantation.
- Assess emerging future practice standards in organ donation and transplantation. Explain cutting-edge, high-quality research in the areas of transplantation, and donation.
- Understand the barriers to equitable access to transplantation, and transplant care and learn strategies to overcome those.
- Recognize principles of equity, diversity, and inclusion with a particular focus on Indigenous cultural sensitivity.

4. TOPICS, SPEAKERS AND MODERATORS

were determined by consensus with input from all committee members.

5. RED HOT Session

The Fellows Symposium will include a 3-hour workshop allowing trainees to use their prior knowledge from prior sessions. This is the last session of this project. All funds from the CIHR grant have been utilized with travel grants and speaker fees

6. CONFERENCE DELEGATES

As of September 12, 2025, more than 337 delegates registered to the meeting.

7. ABSTRACTS, INCLUDING PRESENTATIONS AND POSTERS

a. A total of 130 abstracts have been selected for in-person platform or poster presentation.

8. T3 DRAGONS' DEN COMPÉTITION:

- a. There were 16 applications to the competition
- b. Three competitors will compete for a single prize of \$50k
- c. In addition to delegates voting, three judges representing CST membership, prior winner, and a patient partner will be adjudicating the winner of the competition.

9. SPONSORED SESSIONS

COMMITTEE MANDATE

The Research Committee will advise the Board on matters related to the advancement of basic, clinical, translational, and qualitative research in organ donation and transplantation in the interest of Society member scientists, clinicians, and the public we serve.

The Committee will also advise the Annual Scientific Meeting Planning Committee and make recommendations to achieve an appropriate balance of basic, clinical, and translational research in the scientific program with the goal of showcasing discovery and innovation by Canadian researchers and scientists.

The Committee will communicate with the membership and solicit feedback on behalf of the CST with regards to the needs of the basic science and clinical research communities.

UPDATE

The Research Committee continued with meeting its mandate with an engaged group of members. Please see below a summary of our activities over the past year:

- 1) We have a diverse group of professionals in the fields of donation as well as hematologic and solid organ transplantation, spanning research disciplines from basic research, translational, qualitative and clinical. We have engaged several trainees who are active participants in the committee as well as partnered with CDTRP, whose manager is actively attending the transplant meetings. We engaged in discussions with CDTRP about partnerships in research initiatives that would serve both groups and members. Sunita Mathur presented these ideas to the CST Board in August 2024 for further consideration and next steps. Multiple CST members reached out to the committee seeking to volunteer and assist the committee with accomplishing its goals as well as pushing forward new initiatives. Ruth Sapir-Pichhadze assumed the role of Chair and Daniel Fantus assumed the role of Co-Chair as of 2025.
- 2) The Research Committee contributed to several activities in alignment with priorities outlined by the CST Board:
 - a. The 2025 CST Annual Scientific Meeting (ASM): Several research committee members served as members of the CST-ASM committee to provide suggestions for the conference program. Several committee members participate as presenters and moderators in the scientific sessions.
 - b. Ruth Sapir-Pichhadze co-chaired the scientific abstract reviews. Research committee members reviewed and scored scientific abstracts for the annual meeting, and scores were used to select top abstracts for oral and poster presentations, as well as for awards.
 - c. The lay abstract review was conducted in partnership with the CDTRP with Patient-Family-Donor partners from the CDTRP serving as reviewers. Three top lay

- abstracts were selected for awards that will be presented alongside other abstract awards at the conference.
- d. Research Committee members served as reviewers of applications to the T3 Innovation grant in partnership with the Grants and Awards committee. Ruth Sapir-Pichhadze Co-Chaired the committee.
- 3) The committee established a bi-monthly meeting schedule to serve as a venue for new initiatives put forth by members of the Research Committee and beyond:
 - a. Advocacy for National Data Sharing initiative (put forth by John Gill, Christie Rampersad).
 - b. Updating Research Priorities partnership between CST and CDTRP (review with Patricia Gongal and Marie-Chantal Fortin)
 - c. Initiatives to support CST members/trainees presentations at national and international venues
 - d. Active CST trainee member engagement in committee activities as well as national research initiatives.
 - e. Future initiatives: developing capacity in clinical trials (Ruth Sapir-Pichhadze)

COMMITTEE MANDATE

The Standards Committee (STC) was first confirmed in January 2011. Its initial mandate was to act as a liaison with Canadian Standards Association. The mandate was changed to include making recommendations on developing new minimum standards in the ODT field.

The purpose of the STC is to address issues related to minimum standards in the field of organ donation and transplantation in Canada, on behalf of the CST Board and to provide recommendations to the Board.

UPDATE

The most recent edition of CSA standards was released in Dec 2022. Recent amendments to CSA Z900.1 and CSA Z900.1 & Z900.2.3 were approved by the committee this summer with plans to be released soon.

Meetings for the CSA groups will resume this fall and will increase in frequency with a planned in person pre-planning meeting scheduled for early November. The new edition kick off meeting is scheduled for the spring of 2026 with publication planned for October 2027.

Dr. Jackson Wong Co-Chair Standards Committee Report from CST Student Education Subcommittee – September 10, 2025, by Bill Wall (Chair)

The Subcommittee met twice during the last 12 months (October 8, 2024, and February 14, 2025) and it will meet again this fall.

Two new members have joined: Su-Ling Goh, Senior Communications Advisor, Give Life Alberta and Dr. Jennifer Hancock, Intensivist at QE11 Health Sciences Center in Halifax. Jennifer has special interests in medical education and organ donation, and she leads the province's Continuous Renal Replacement Therapy Program. Su-Ling was previously a health reporter and news anchor with Global News in Edmonton.

The interests and goals of the Subcommittee continue to be enhanced by the fact that most of our members (including our two newest) also participate in the Public Education and Awareness Committee (PEAC) forums of the Organ and Tissue Donation and Transplantation (OTDT) branch of Canadian Blood Services (CBS). Student education is as a very significant part of the PEAC mandate, and it has resulted in the establishment of the education portal learn.organtissuedonation.ca

The website is a comprehensive repository of educational materials and curricula from kindergarten through Grade 12 for students, teachers, and parents. Our Subcommittee receives regular information From Jenny Ryan about resources on the website, and specific reports from individuals such as Lucie Dumont who detailed an extensive evaluation by two university researchers on the Chain of Life curriculum at our February meeting (Bedard J and Bisset S (2024). Organ and Tissue Donation in the Classroom; Chain of Life's Education Program from Quebec. Evaluation Report (J Rohlf, Trans.). University of Sherbrooke, Faculty of Education.

The evaluation was very positive. It validated the worth and success of the course, which is now under consideration by the government of Quebec for official inclusion in the civics curriculum in addition to the English as a Second Language course where it's been taught for more than 10 years. Also, Chain of Life is being adapted this year for grade 12 students in the Language Art Program in British Columbia. It's a perfect example of how an existing, proven educational resource in one province can be modified with minimal change to meet Ministry of Education criteria in another province.

Over the past 12 months, Subcommittee members have personally participated in a variety of roles in classrooms to educate students on the topic of organ donation and transplantation. Some examples are Vicky Ng and the High School Outreach Initiative and Mike Moser's student program in Saskatchewan. Suling's enthusiastic book reading of the ant who needed a transplant in 14 schools during Read-in Week in Alberta was featured in a newsletter from Alberta Health Services (see attached). Give Life Alberta is intent on establishing a culture of donation throughout the province, and she's made student education an integral part of that effort. A number of others, including myself, have done book readings of the ant who needed a transplant during the school term.

Last year CBS introduced the term Orgtober to designate October as the month to teach the Orgamites to children in kindergarten to Grade 3. It will hopefully become a yearly routine in elementary schools. Next month in Ottawa (Orgtober 16th), there will be the launch of the Mighty Orgamites, a travelling exhibit at the Museum of Science and Technology. It is interactive and designed to stimulate young minds to learn about their health, their mighty organs, and the power of organ donation. Prior to the launch, an education

mini summit will be held to discuss student education on donation and transplantation. I will be participating.

Each year, it becomes more and more evident that our subcommittee interactions with CBS, the PEAC, provincial Organ Procurement Organizations, schools, and others reflect a common understanding of the importance of educating Canadian youth about organ donation.

1) NAPS Study in SOT:

The study on Audit of antibiotic prescription in SOT has concluded, and data analysis is ongoing. The Principal Investigator is Dr. Shahid Husain.

2) HIV and Kidney Transplant Study:

A national study comparing access to kidney transplantation and graft outcomes between HIV-positive and HIV-negative patients with end-stage renal disease (ESRD) is underway, utilizing provincial databases. The Principal Investigator is Dr. Sasan Hosseini.

- 3) <u>EASE Antibiotic Study:</u> This study, led by Dr. Shahid Husain, compares short versus long durations of antibiotics in patients with febrile neutropenia.
- 4) Canadian SOT Antifungal Prophylaxis Study (CAN-SOT-AFPRO): Practices, Triggers, Agents, and Outcomes Across CST Centers. S Hosseini
- 5) Pan-Canadian registry of invasive mold infections post-transplant, capturing risk factors, treatment, and outcomes. S Hosseini
- 6) Pneumocystis pneumonia: current prophylaxis strategies across transplant centres, duration and outcome: Sasan Hosseini
- 7) NTM colonization/disease pre transplant and outcomes in LTRs: Dima Kabbani

Potential Collaboration:

There is a potential collaboration with the Special Immunization Clinic (SIC) research group to explore live virus vaccines in immunocompromised patients, including select SOT recipients. The project will begin with the pediatric population, with Catherine Burton as co-Principal Investigator.

Grants and Awards Committee (GAC) Annual Report 2025

Summary: During the last year, the GAC has reviewed and awarded the 2025 Research Training Awards and Career Awards and participated in the review and selection for the T3 Grant Competition Finalists.

Research Training Award: This award consists of 3 awards of \$20,000 each. We received 18 applications for the Research Training Award. The awardees are:

- #1 Daniel Vosoughi PhD, Supervisor Dr. Stephen Juvet at the University of Toronto, Lung Autoantibodies as Biomarkers and Mediators of Chronic Lung Allograft Dysfunction with an average score of 4.46.
- #2 Anudari Zorigtbaatar PhD, Supervisor Dr. Gonzalo Sapisochin at the University of Toronto, Evaluation of the Economic Burden of Liver Transplantation in Canada: A Single-Center Study (ECONLIVER) with an average score of 4.38.
- #3 **Dr. Roni Bitterman** MSc, Supervisor Dr. Syed Hosseini Moghaddam at the University of Toronto, *Incidence and Outcomes of Invasive Candidiasis in Solid Organ Transplant Recipients in Ontario- a Population-Based Cohort Study* with an average score of 4.32

We also discussed the following changes to the Terms of References (TOR):

- A supervisor may be the primary supervisor on a maximum of 2 applications.
- Applications that do not meet the TOR eligibility criteria, or are incomplete (i.e. missing any component of the application), or do not adhere to the maximum page/word limits will be disqualified without notification (i.e. will not be reviewed/scored).
- We adjusted the multiplier for MSc and PhD applications to give more weight to the research project itself.

<u>Career Awards</u>: The 2025 CST Career Awards are intended to recognize leaders in transplantation in the fields of education, clinical, leadership, research, and lifetime achievement. The awardees are:

- Lifetime Achievement Award: **Dr. John Gill**, University of British Columbia
- Clinician Recognition Award: Dr. Dana Baran, McGill University
- Education and Teaching Award: Dr. Eric Yoshida, University of British Columbia
- Excellence in Leadership Award: Dr. Lakshman Gunaratnam, Western University
- Research Excellence Award: Dr. Mamatha Bhat, University of Toronto

<u>T3 Grant Competition in Transplantation and Donation</u>: Members of the GAC also participated in the T3 Grant Competition. Overall, there were 16 submissions and 8 were invited to submit a full application for consideration. The top 3 applications that were chosen to move forward to the Dragon's Den competition were:

- Dr. Tereza Martinu, University Helath Network, Investigating the relationship between lung allograft microbiome composition, short-chain fatty acid
- Dr. Shaifali Sandal, McGill University, Are Decision and Teaching Aids used by Canadian
 Transplant Programs Contributing to Inequities in Transplantation? A Critical Discourse Analysis
- Dr. Aizhou Wang, University Health Network, A clinical study to evaluate impacts of the human decedent model on healthcare workers and donor families

CST Kidney Working Group Report of Activities – 2025

The mission of the Kidney Working Group (KWG) is to advance the practice of kidney transplantation in Canada through:

- 1. Attention to national issues in kidney transplantation including the setting of guidelines, standard protocols, and policies;
- 2. Promotion of kidney transplant research;
- 3. Development and support of national kidney transplant registries and databases;
- 4. Education (promoting professional development including fellowship programs and other educational programs; and
- 5. Advocacy for patients who require or have undergone kidney transplantation.

The CST KWG meetings at the CST Annual Scientific Meeting in October 2024 were great successes at re-invigorating national interest in the Kidney Working Group. The first KWG meeting during the CST ASM was dedicated to organizational updates from national groups like Canadian Blood Services and CIHI, as well as highlight special projects and initiatives from around the country. The second meeting addressed kidney transplantation in the elderly as a controversial topic in transplantation, including a presentation from national expert in the field Dr. John Gill as well as discussion of national survey results and Canadian transplant metrics. The meeting concluded with solicitation of other contentious topics in transplantation for discussion at the next scheduled KWG meeting.

In 2025, the group work has primarily focused on the CST Kidney Transplant Workforce Project looking at programmatic resources required to run an efficient and effective transplant program. A national steering committee comprised of medical, surgical, pediatric, pharmacy and nursing expertise was formed and a survey was developed. This survey compiled the current FTE of physicians, nurses, pharmacists, social workers, coordinators, data clerks, unit clerks, and more from the Canadian adult and pediatric transplant programs in order to benchmark the current resources per unit transplant. The goal will be to present the data we have accumulated thus far at the CST ASM in 2025 and decide on future directions of the project with the group. The ultimate product of this is meant to be a white paper document from the CST of recommendations that will assist Canadian programs to lobby for resources within their provincial and national frameworks.

The CST KWG has also been preparing for the CST ASM in Vancouver in October 2025. The KWG meeting will be a full-day event on October 7, 2025. The day will include organizational updates from national groups like Canadian Blood Services and CIHI, as well as highlight special projects and initiatives from around the country with special attention to Dr. Paul Keown's Canadian Molecular Matching Program. The program will conclude with a discussion of the CST Kidney Transplant Workforce Project and the data generated thus far.

The goal before the next CST ASM will be to have a single virtual forum in spring 2026 again highlighting controversial topics in transplantation voted upon by the group at the CST ASM in 2025. This will include presentation of the results of a distributed national survey from the KWG, as well as a talk from a national expert in the field of interest.

CST LUNG TRANSPLANT SECTION CHAIR'S ANNUAL REPORT 2025

GENERAL UPDATES

Dr. Aman Sidhu, lung transplant respirologist from the University of Toronto/Toronto Lung Transplant Program, took over as Lung Section Chair for 2025-2026 after serving as Co-Chair for 2023-2024. We thank Dr. Roland Nador for his time as Lung Section Chair in 2023-2024.

We are fortunate that Dr. Kieran Halloran, lung transplant respirologist from the University of Edmonton/Edmonton Lung Transplant Program, has accepted the position of Co-Chair for 2025-2026, and will be the next Chair from 2027-2028.

The CST Lung Section is very pleased to have members involved in the CST Annual Scientific Meeting Planning Committee. We will have excellent in-person attendance for the Vancouver meeting with several speakers and moderators participating in the Fellows Symposium and Scientific meeting. Thank you to the CST for facilitating the re-invigoration of the Canadian lung transplant community's involvement in the CST!

SUMMARY OF ONGOING AND UPCOMING INITIATIVES

Canadian Lung Transplant Research Network:

This subgroup formed by members of the CST Lung Group fostering and nurturing research collaboration among the Canadian Lung Transplant Centers. Multiple projects have been initiated via this platform. Ongoing projects include: CFTR modulator post-transplant in cystic fibrosis lung transplant recipients, outcome of lung transplant recipients receiving MAID donors, and outcome of lung transplant recipients bridged with ECLS to transplant.

Canadian Consensus Statement on pre-transplant inhaled substance use:

This initiative was stemming from the need to educate and inform the public about the different forms of inhalation substance use, their impact on lung health, disease progression and their role in lung transplant candidacy. The initial discussion by the group decided to focus on legal inhaled substances (cigarette, tobacco, marijuana) and the different forms of delivery (smoking, vaping), with a focus on abstinence criteria and the support for inhaled substance use cessation before and after lung transplantation.

Lung Transplant Satellite Program – Canadian Working Group

There are 4 lung transplant surgical programs in Canada with a vast catchment geography. Many of the Canadian Programs work with satellite sites but there are varied practices with respect to the roles and responsibilities of a satellite care program. Dr. Meredith Chiasson from Halifax, who leads the Halifax Lung Transplant Satellite program affiliated with the Toronto Lung

Transplant Program will lead a working group to collaborate on best practices for satellite lung transplant care in Canada. We aim to publish a white paper on this topic.

<u>Outcomes of Lung Transplant and Consensus Approach in MDA5 Positive Anti-Synthetase</u> Syndrome

There has been growing interest across the lung transplant community in exploring the approach to management, assessment of lung transplant candidacy, and outcomes of lung transplantation in this difficult and often rapidly progressive/fulminant disease. Dr. Ciaran Scallan from the Toronto Lung Transplant Program is leading a collaborative effort to examine cases of MDA5-associated ILD to inform practice. The specific aims of this effort are to look at the impact of pre- and post- transplant management (immune suppression, ECMO, infection management), as well as post-transplant outcomes (rates of BLAD/CLAD/rejection, post-transplant infections, health related quality of life, graft survival/overall survival). The project is well underway and will allow the examination of a large cohort of these patients, making for a very impactful study with a high level of interest to the global lung transplant community.

Annual CST Lung Group Educational and Business Meeting:

We will continue these annual meetings in conjunction with the CST Annual Scientific Meeting. In recent years this meeting was held at the end of the conference virtually. We have elected to hold the meeting as a hybrid in-person and virtual session on October 9th. We will continue to have a keynote speaker and discuss important Lung Section initiatives. The Joel Cooper Award for Achievements in Lung Transplantation will be awarded every 2 years and presented at this session.

A NOTE TO THE BOARD:

We continue to be motivated to work with the board on increasing the involvement of the Lung Transplant Section in the CST Annual Scientific Meeting as well as the Society as a whole. We are interested in facilitating interest in participation and leadership in CST Committees from members of the Canadian lung transplant community. Our goals are to have members of the Lung Transplant Section on the Board of Directors in coming years. The Lung Section Leadership will encourage nominations for these positions as opportunities arise. We appreciate in advance the support of the Board and advice on bolstering our ongoing involvement and presence in the CST.
